## SREDA LAUNCHES SMALL BUSINESS EMERGENCY CONTINUITY GRANT PROGRAM

Today, we launched Phase 1 of the **SREDA Small Business Emergency Continuity Grant Program** designed to support the local economy during these challenging times. The program will provide grants of up to \$5,000 to small businesses in the Saskatoon Region that are experiencing significant financial challenges because of the COVID-19 pandemic.

To be eligible for a grant, businesses must have experienced a substantial downturn in business activity related to the outbreak of COVID-19, resulting in significant financial challenges. They must also:

- Operate in the Saskatoon Region
- Be a for-profit commercial business
- Have 10 or fewer employees, including owner(s)
- And have been in business for more than 6 months but less than 5 years.
